

President Mohiuddin Syed is abusing his position as Board President to corrupt the election process

- On August 25th he voted in secret to keep a rival candidate off the election ballot – a blatant conflict of interest since he is also a candidate in the election – and a direct violation of state law.
- He declined management's offer to include a corrected ballot in a new mailing with all 7 profiles. Suddenly he stops listening to the "professionals" when it doesn't suit him.
- The same day he excluded two other Board members from a secret conference with the Association's attorney to discuss the defective ballot – another direct violation of state law.
- And when his actions were exposed to the community by another Board member, he is trying to remove that Board member from the Board for releasing "confidential board information", another malicious violation of state law. He actually kicked off another member earlier this year.
- He illegally banned two of his other rival candidates from attending the August 27th candidate's night event in person.
- He has weaponized the Association's attorney against owners that complain too loudly, trying to silence them by sending threatening and intimidating letters.
- And don't forget about the **\$97/month fee increase** we all received this January. Mohiuddin Syed was the deciding fourth vote in favor of that motion.

Is this the person we want leading Society Hill??

I am **Zahid Khan** – I have been "accidentally" left off the paper ballots which is still how 370 owners can vote in this election. **You will have to vote for me as a "Write-In" (see other side).** I was also the one kicked off the Board in March of 2025 essentially over \$4, while another trustee with a much larger balance was left alone for over a year.

I am **Vincent Marchitto** – They want to silence me for complaining about the drainage/flooding issue behind my building and the botched solution 2 years ago.

I am **John Fakla** – I was arbitrarily banned from the candidate's night meeting for no legitimate reason. Apparently there are no free speech rights in the Kingdom of Society Hill.
